Resolution Regarding Valet Parking application for Maggiano's; DDOT tracking #10112372

Whereas, Maggiano's Holding Corporation doing business as Maggiano's Little Italy (Maggiano's) located at 5333 Wisconsin Avenue NW has applied to the District Department of Transportation (DDOT) for a permit to provide valet parking to its restaurant patrons, and

Whereas, MarcParc Valet will manage valet parking at this site on behalf of Maggiano's, and

Whereas, MarcParc Valet previously managed valet parking operations on behalf of Maggiano's until the end of 2012 and ANC 3E is unaware of any complaints about that management, and

Whereas, MarcParc Valet has submitted plans that indicate that they will park all vehicles they are responsible for off street in the parking lot underneath the Chevy Chase Pavilion (the Pavilion) at 5335 Wisconsin Avenue NW, and

Whereas, MarcParc Valet has submitted plans that indicate they will move vehicles between their staging area in the lay-by lane in front of Maggiano's and the parking lot beneath the Pavilion by proceeding north on Wisconsin Avenue for approximately 40 feet and turning right to enter the Pavilion, and

Whereas, MarcParc Valet has submitted plans that indicate they will return vehicles from the parking lot beneath the Pavilion by exiting the parking lot on Jenifer Street, turning right (westbound) and then making a second right at Wisconsin Avenue to head northbound for approximately 100 feet back to the lay-by lane where the vehicle will be returned to its owner, and

Whereas, MarcParc Valet has committed to never park, idle or otherwise temporarily store any cars they are responsible for in either on street metered parking spaces, on street commercial spaces, on street delivery zones or on-street residentially zoned parking spaces, and

Whereas, MarcParc Valet has only applied to begin offering valet parking services after 630PM Monday through Friday when the furthest right/easternmost northbound lane of Wisconsin Avenue reverts from being a travel lane back to a parking lane, and

Whereas, MarcParc Valet has committed to never deliberately blocking a travel lane of Wisconsin Avenue in the process of providing their valet parking services, and

Whereas, MarcParc Valet has expressed a desire to commence valet parking operations earlier than 630PM Monday through Friday but DDOT indicated they would not support operations

starting earlier because of PM rush hour parking restrictions despite the availability of a lay-by lane, and

Now therefore be it resolved, that ANC 3E supports Maggiano's application to have MarcParc operate a valet parking operation predicated on the applicant's adherence to all of the conditions listed above.

ANC 3E approved this resolution at its meeting on September 19, 2013, which was properly noticed and at which a quorum was present. The resolution was approved by a vote of 5-0-0. Commissioners Jonathan Bender, Matthew Frumin, Tom Quinn, Sam Serebin and Kathryn Tinker were present.
