Resolution Regarding Valet Parking application for Rosa Mexicano; DDOT tracking #10048790

Whereas, Rosa Mexicano Restaurant located at 5225 Wisconsin Avenue has applied to the District Department of Transportation (DDOT) for a permit to provide valet parking to its restaurant patrons, and

Whereas, MarcParc Valet will manage valet parking at this site on behalf of Rosa Mexicano, and

Whereas, MarcParc Valet has submitted plans that indicate that they will park all vehicles they are responsible for off street in the parking lot behind Gawler's Funeral Home at 5130 Wisconsin Avenue NW, and

Whereas, MarcParc Valet has submitted plans that indicate they will move vehicles between their staging area in front of Rosa Mexicano and the parking lot behind Gawler's Funeral Home by utilizing the left turn arrow from northbound Wisconsin to westbound Jennifer Street and then by making a left turn onto southbound 44th Street and then by making a left hand turn onto eastbound Harrison Street and then entering the parking lot from Harrison Street, and

Whereas, MarcParc Valet has submitted plans that indicate they will return vehicles from the parking lot behind Gawler's Funeral Home by exiting the parking lot and heading eastbound on Harrison Street and then utilizing the traffic light at Harrison and Wisconsin to turn left to northbound Wisconsin Avenue, and

Whereas, MarcParc Valet has committed to never park any cars they are responsible for in either on street metered parking spaces, on street commercial spaces or on-street residentially zoned parking spaces, and

Whereas, MarcParc Valet has indicated that it intends to take no more than 3 on street metered parking spaces in the 5200 Block of Wisconsin Avenue on the east side of the street between Jenifer and Ingomar Streets, and

Whereas, MarcParc Valet has submitted an application indicating that they wish to begin offering valet parking services at 5PM Monday through Friday but that service would require taking over travel lanes on Wisconsin Avenue during that time period; MarcParc Valet has indicated that they will amend their application and only apply to begin offering valet parking services at 630PM when the furthest right/easternmost northbound lane of Wisconsin Avenue reverts from being a travel lane back to a parking lane, and

Whereas, MarcParc Valet has committed to never deliberately blocking a travel lane of Wisconsin Avenue in the process of providing their valet parking services and this commitment

includes not setting up their operations prior to 630PM Monday through Friday excepting Holidays, and

Whereas, in their voluntary agreement with ANC 3E Rosa Mexicano agreed to provide free valet parking for any customers arriving after 10PM and MarcParc Valet has committed to adhering to this clause in the voluntary agreement, and

Now therefore be it resolved, that ANC 3E supports Rosa Mexicano's application to have MarcParc operate a valet parking operation predicated on the applicant's adherence to all of the conditions listed above.

ANC 3E approved this resolution at its meeting on February 9, 2012, which was properly noticed and at which a quorum was present. The resolution was approved by a vote of 5-0-0. Commissioners Jonathan Bender, Matthew Frumin, Tom Quinn, Sam Serebin and Beverly Sklover were present.
